### National University

**T**he *Jeanne Clery Disclosure of Campus Security Policy and Campus Crime Statistics Act* (20 U.S.C. Section 1092(f)) requires that institutions of higher education disclose information about campus safety policies and procedures and crime statistics to all current faculty members, staff and students, and to make such information available to prospective faculty members, staff and students, if requested.

National University, by its very nature (a University without onsite residence halls or typical college social activity) is not as susceptible to onsite crime as are its sister institutions. However, prudence requires that each of us pause and reflect on what we can do to help prevent crime before it occurs; how we should react if we are the victim (or witness) of a crime; and the action we should take once a crime has occurred.

This annual report highlights areas of which each of us should be aware and actions which we can take as individuals, and collectively, to help reduce our exposure to criminal acts. Please review the information contained herein and, if you have any recommendations as to how the University can better prevent onsite crimes, or respond to crimes which have occurred, we would like to hear from you.

# NATIONAL UNIVERSITY Annual Campus Security Report 2009

Crime Prevention is the responsibility of each person working at, attending school at, or visiting, a University facility. Crime prevention is best served by the vigilant surveillance of the premises and reporting any suspicious personal behavior. Each person should have a preconceived plan of action in the event they should become involved in, or be a witness to, a criminal act. By following the below-listed generally prudent rules, each employee or student will help ensure that they will not become the victim of a crime:

- Park your car in University-designated parking areas, if possible.
- Do not leave items in your car which are visible from the outside; rather, place the items in the locked trunk of your car, or under a car seat, if possible.
- Lock all car doors, and check them, before leaving your parked car. Keep your car key in your hand until you are in a well-lighted, or heavily-trafficked area. This will allow you to rapidly re-enter your vehicle, should you see a suspicious person in the area.
- You may want to invest in a mechanical locking device, or electronic alarm system for your car. If you have such a device/system, ensure that you use it each time you park your car.
- Be alert for strangers in the classroom or work area. If you see an unfamiliar face in the vicinity, proceed to your work/class area, then report the matter immediately.
- If you work in a University office, get in the habit of closing and locking your office door each time you must leave the office unattended.
- Do not leave valuable articles in open view in your office; place them in a locked desk drawer or in a sheltered location.
- Have a plan of action in mind, should you be accosted. If you have an authorized anti-personnel protection device (e.g., mace or pepper spray) with you, ensure that it is readily accessible and ready for use.
- In case of a personal attack, scream as loudly as you can and run toward a more lighted or highly trafficked area. Do not voluntarily enter an assailant's automobile, or go with an assailant to a more remote location.
- If you are a woman and find yourself cornered or in a dangerous situation, kick your assailant as hard as you can in the groin; you have much more strength in your legs than in your arms.
- If an assailant demands your money, you may want to take out a pre-positioned amount of money and throw it away from you and then take off running as fast as you can, in the opposite direction.
- Try to note the size and physical characteristics of your assailant, as well as the color and make of car (if appropriate), and give the person to whom you are reporting the crime as much information as you can.
- Should you be accosted, give the assailant your purse or wallet and do not attempt to resist.
- If you are not able to report the crime immediately, jot down your recollections so that you can better recall the information when you do report the crime.

## Drug and Alcohol Abuse Prevention

## Campus Security

National University provides academic advising services and/or offers academic classes at various locations throughout California. Security at these various locations is provided as indicated below.

- **University-Owned Facilities:** National University contracts with licensed commercial agencies for onsite security services at facilities it owns. Security personnel at University-owned facilities are under the administrative direction of the Director of Facilities, but report operationally to the Associate Regional Dean at the applicable campus.
- **University-Leased Facilities:** The University or the landlord of University-leased facilities provides security services for the facilities. Security services are coordinated on behalf of the University through the Associate Regional Dean in the regions outside of San Diego, or the Director of Facilities, in San Diego.
- **University-Licensed Facilities on Military Installations:** The governmental agency (military branch) from whom the

University licenses office/classroom space is responsible for security of the facilities used by the University. The Associate Regional Dean, Military Base Programs, in San Diego, and the Associate Regional Dean, San Bernardino, interface with military base security personnel, in ensuring compliance with applicable base security policies and reporting of security violations.

- **Classes Held off Campus at an Employer’s Site.** The employer upon whose premises the University conducts classes is responsible for security of its premises. The Associate Regional Dean in charge of the University campus closest to the employer’s premises interfaces with the employer to ensure compliance with the employer’s security policies and reporting of security violations.

### Access to University Facilities

National University does not restrict access to any of its owned facilities. Access to leased, licensed, or employer-owned facilities may be controlled, during specified hours, by the landlord or employer.

### Security Personnel

In general, National University security personnel are unarmed and may only make a “Citizen’s Arrest” of a person who is in the act of committing a crime, or is reported to have committed a crime. Security personnel are instructed not to attempt to apprehend a suspect, unless the person is caught in a criminal act. Security personnel maintain close liaison with local police departments and keep them apprised of any criminal activity on campus. Local police may be called when appropriate by either security personnel or the senior administrator or staff person on campus.

### Reporting

Report any criminal offense or possible criminal offense you witness or are a victim of to the Associate Regional Dean in charge of the campus you are on as soon as practicably possible, and to security personnel if they are present at the time the crime takes place. If no one is available to meet with you in person, call the National University switchboard (1-800-NAT-UNIV) to report the crime. If you or someone else is in danger and/or University personnel or security personnel are not there to assist you, call “9-1-1” (9-9-1-1 from a University extension) and make your report directly to the local city police, following up with a report to the appropriate Associate Regional Dean or security personnel at your earliest opportunity.

In all cases, any security violations or crimes that occur at any National University location, which is leased, owned or licensed, or any offsite location at which the University provides classes, shall be communicated through the applicable Associate Regional Dean to the Director of Facilities, with notification to all University Vice Presidents, and to the Director of Human Resources if the incident involves an employee as a victim. Any security violations or crimes that occur at University headquarters in Torrey Pines shall be communicated through the Manager of Administrative Services to the Director of Facilities.

The University will investigate and take action, as it deems appropriate, in the event of a report of criminal activity.

The University will alert staff and students in the event a pattern of criminal activity becomes apparent (e.g., a number of automobile break-ins or assaults on visitors in a specific geographic area).
