Health Insurance Policy

CSULB requires all F-1 visa holders to purchase health insurance through our contracted insurance broker, JCB Insurance Solutions. No exceptions [or waiver]. This policy will provide U.S. medical coverage from August 10 – December 31, 2021 and cost \$526.83. Instructions on how to purchase will be sent at a later date.

What immunizations are required to study at CSULB?

CSULB requires all students to show proof of immunity for the following during their study. You may read more about the requirements by clicking here.

COVID-19

o As of <u>January 2021</u>, a negative test result within 3 days of travel is required by airlines to enter the U.S. Please check with your airlines for more information.

o All California universities will make it mandatory to be vaccinated for COVID-19 before the start of Fall 2021 classes. This means international students will need to complete their final vaccination by August 22, 2021. If you are planning on living in on-campus housing, you will need to be vaccinated before move-in. Please contact the housing office at XXX for move-in dates and deadlines.

o If you are eligible to be vaccinated in your home country before entering the U.S., please do so! You can submit your proof to XXX, along with your other immunizations for clearance. Website: www.csulb.edu/studyabroadatthebeach o If you are not able to be vaccinated in your home country, please plan to arrive in Long Beach up to 3 weeks before classes begin to receive the 2 doses of the vaccination, 21 days apart. (The Johnson & Johnson vaccine is 1 shot, however we don't know if the vaccination will be available at CSULB or the surrounding areas yet.) CSULB will make student vaccination appointments available using your MyCSULB student account as soon as the FDA approves the vaccinations from emergency to full approval.

Measles, Mumps, and Rubella (MMR): 2 doses on or after the first birthday **OR** laboratory test to show proof of immunity (titer). If you have both an immunization and titer, please upload the immunization record only, not both the immunization and the titer.

Varicella (Chickenpox): 2 doses on or after the first birthday **OR** laboratory test to show proof of immunity (titer). If you have both an immunization and titer, please upload the immunization record only, not both the immunization and the titer.

Tetanus, Diphtheria, and Pertussis (Tdap): One dose on or after the age of 7 years.

Hepatitis B (students 18 and younger)

Meningitis ACY-W (Menactra or Menveo) – Required for all students 21 and younger and required for all housing students (regardless of age): One dose on or after the age of 16.

Meningitis B (Trumenba or Bexsero) – Required for Housing students only: Students who will be living in housing must complete all doses prior to moving into housing.

Tuberculosis -Incoming students who are at higher risk for TB infection should undergo either skin or blood testing for TB infection within 1 year of entry into CSULB. Non-high risk countries include: Albania, Andorra, Antigua & Barbuda, Australia, Austria, Bahamas, Barbados, Belgium, Canada, Chile, Costa Rica, Croatia, Cyprus, Czech Republic, Denmark, Egypt, Finland, France, Germany, Greece, Hungary, Iceland, Ireland, Israel, Italy, Jamaica, Japan, Jordan, Lebanon, Luxembourg, Macedonia, Yugoslav, Malta, Monaco, Montenegro, Netherlands, New Zealand, Norway, Oman, Samoa, Saudi Arabia, Slovakia, Slovenia, Sweden, Switzerland, Syria, UAE, UK, USA.
