Work Options for International Students

» Students can apply for work on-campus, off-campus, and after graduation.

Work On-Campus or Off-Campus

Eligible students may work up to 20 hours per week per semester, and full time during scheduled breaks in the school year.

Co-operative Education

Selected program areas provide co-operative education options that combine academic studies with paid work experience.

Students alternate between terms of full time study and full time employment.

Exchange Programs and Field Schools

TRU Study Abroad offers international students the opportunity to study one or two semesters outside of Canada, further broadening the student's global experience.

Currently, TRU engages in more than 40 exchange agreements with partner-institutions in South America, Asia, and Europe.

TRU is one of only three Canadian institutions with membership in the Washington, DC-based International Student Exchange Program. As an ISEP member, TRU participates in more than 200 additional exchange programs in 35 countries.

Field Schools

TRU operates a number of specialized field schools in which faculty-led student groups undertake studies or research abroad. Currently, TRU offers an Anthropology field school in East-Central Europe; an Adventure Tourism field school in Chile; practicum placements for the School of Nursing in Thailand and Samoa; a Social Work field school in Mexico; and field studies in Natural Resource Science in Belize.

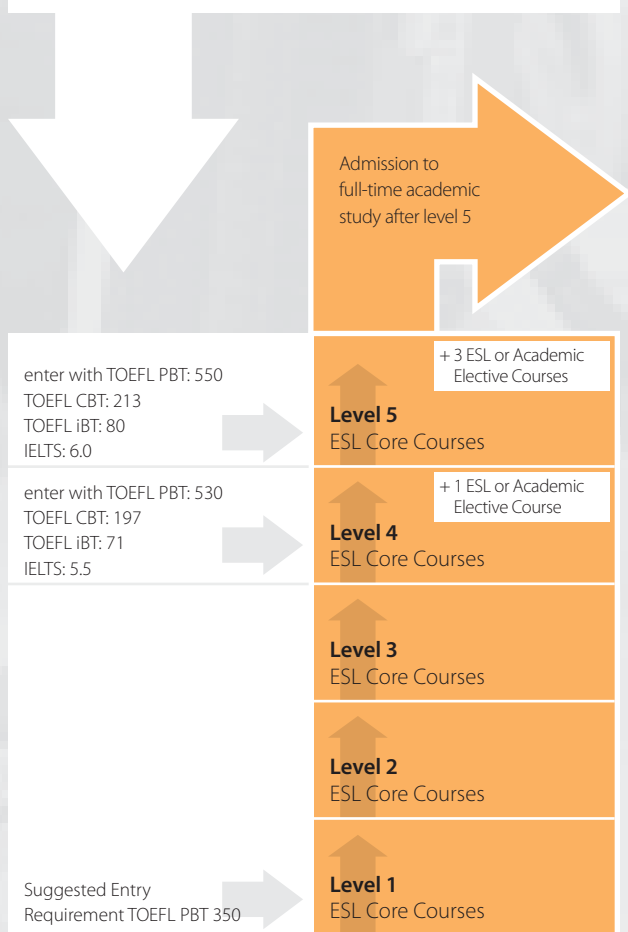


TRU Program Guide

English Language Programs

Each of the five levels of TRU's ESL program takes one semester to complete. Students can expect 20 hours of classroom study each week, with additional time in independent study, multimedia and/or language labs, and social activities.

- » **ESL Core Courses:** Instruction for skills development in reading, writing, speaking, and listening.
- » **ESL Electives:** Optional courses that focus on specific topics or skills.
- » **Academic Electives:** Elective courses from TRU's academic programs.



ESL Bridging Certificates

Each requires completion of Level 4, one ESL elective, and two specific academic courses. Minimum time required: two semesters.

- » English and Sciences
- » English and Liberal Arts
- » English and Fine Arts
- » English and Business

ESL Advanced Academic Preparation Certificate

Requires completion of Level 5, including an ESL elective and two additional elective courses.

ESL Academic Preparation Certificate

Requires completion of Level 4, including one elective course.

ESL Intermediate Certificate

Requires completion of Level 3.

ESL Foundations Certificate

Focuses on basic English skills. Requires completion of Level 2.

TOEFL Exam Formats

TRU Pathway Partners

TRU has established pathway programs with partner-institutions in Europe, the Americas, and Asia to support the transfer of qualified students for academic studies at the TRU campus in Kamloops. Please see: truworld.ca for details.

Customized Training for Groups

TRU develops many customized group training programs, with particular strengths in specialized English as a Second Language (ESL) training, ESL study tours, ESL + specific purposes programming (such as ESL/Business, ESL/Tourism, ESL/Nursing), English teacher upgrading, and executive leadership.

Programs can include:

- » Customized instruction in Canada and/or in the client's home country
- » Cultural benefits such as guest speakers, site visits, and community placements

- » Recreational activities such as golf, fishing, hiking, horseback riding, skiing, and other field trips and experiences
- » A choice of residence, homestay, or apartment accommodation
- » A complete range of support services, often including support in the participant's native language

Innovation and Excellence in EFL Teaching

This certificate program consists of five courses comprising 5–8 weeks of full-time study and immersion in Canadian culture. Participants

will learn the latest techniques in teaching EFL (English as a Foreign Language), become more competent in English, explore Canadian culture, and actively improve their classroom delivery. Each group will work with at least five different faculty members with expertise in teaching English. Clients include the State Administration of Foreign Experts Affairs (SAFEA), Pudong, Hong Kou, Changning, Haungpu, JiaDing, and Jing'An Education Bureau.

Executive Training

Drawing on its international project expertise, TRU designs and delivers specialized training programs for managers and executives from all fields. TRU has hosted multiple groups of educators and school principals for English-language upgrading and executive leadership training. Trainees participate in English-language training, human resource training, leadership training, and cultural and recreational

activities—including professional placements with Canadian educators. Clients include the Haidan Education District and the Xuhui District Government, both of the People’s Republic of China.

English-Language Study Tours

TRU receives multiple student groups every year for ESL study tours that combine English-language training with cultural and recreational activities. Participants are encouraged to select the homestay option, which provides a full immersion experience. Clients include Kyoto Bunkyo Junior College in Uji City, Japan, Nova Group, based in Tokyo, Japan and Korea’s Induk Institute of Technology.

Open Learning

TRU Open Learning (TRU-OL) offers access to over 400 courses and 52 programs via distance delivery, including 27 bachelor's degrees in disciplines ranging from Arts to Technology and Health Sciences to Business. Over 10,000 students per year are supported by more than 100 dedicated and fully credentialed tutors.

Enrolment in courses and programs can take place at any time and from anywhere, with fewer restrictions on admissions. Students complete courses by studying on their own with the instructional support of tutors who are available by email, phone and in some courses, video conferencing.

3. TRANSCRIPTS

With this application submit official transcripts (or certified copies) of your secondary school grades and any post-secondary institutions you have attended. Transcripts must be officially translated into English. You may scan and email or fax the transcripts for faster processing but originals must be presented on arrival to TRU. Otherwise you will not be allowed to register for courses at TRU.

4. APPLICATION FEE

A non-refundable application fee of CDN\$100 must accompany your application.

3 Next Steps:

1. PROCESSING

Your application will be processed within two working days.

2. PRE-ACCEPTANCE

TRU will send a pre-acceptance letter indicating:

- (a) The program to which you have been accepted
- (b) Any conditions of your acceptance

3. SUBMIT

You should submit:

- (a) Required fees for your first semester of study (as outlined in your pre-acceptance letter)
- (b) Your program selection plan

4. FINAL ACCEPTANCE

Upon receiving payment of tuition and general fees, TRU will send an official letter of acceptance.

5. HOUSING

6. STUDENT VISA

Use your official TRU letter of acceptance to apply to the nearest Canadian Embassy or Consulate for a student visa.

7. AIRPORT PICKUP

Make arrangements for airport pickup.

4 Payment:

TRU REFUND POLICY

Students should familiarize themselves with TRU's refund policy prior to submitting payment for their studies.

International students who:

- (a) Withdraw prior to the start of instruction will receive a 50% refund of tuition and general fees invoiced.
- (b) Withdraw in the first or second week of instruction will receive a 25% refund of tuition and general fees invoiced.
- (c) Withdraw after the second week of instruction will receive no refund of tuition and general fees.
- (d) Withdraw due to a failure to obtain a student permit prior to arrival at TRU will be entitled to a full refund of tuition and general fees invoiced less a CDN\$200 administration fee. Students must notify TRU in writing and provide documentation prior to the start of the semester (the original letter from the Canadian Embassy stating the reasons the visa was denied is required — no photocopies or faxes are accepted). Total nonrefundable including application fee of CDN\$100 is CDN\$300.
- (e) Students who wish to defer their application to the next semester must do so prior to their arrival in Canada. Once instruction begins policies (b) and (c) above apply.

Bachelor of Science

TRU offers three routes into this four-year degree program: a Major in a specific discipline, an Honours program (currently available only in Biology), or a General Science degree.

The Major program is intended for students wishing to specialize in a single field of science. Students in a Major program may also complete a Minor in a discipline or disciplines outside their Major.

The General Science Program gives students a broad education in science. Students can specialize in the third and fourth years in two or more areas of life science (biochemistry, biology, and microbiology), chemistry, mathematical and computing science, and physics. Graduates will be well prepared to pursue further studies in Education, Medicine, Dentistry, Veterinary Medicine, and more.

Graduate Degrees

Master of Science in Environmental Science

The MSc degree in Environmental Science requires the completion of 28 credit hours, including two core courses, elective courses, and an independent research project culminating in a thesis. Students will select one of three concentrations (Ecology and Evolution, Physical Sciences, Policy and Management), depending on their research interests.

All students, regardless of concentration, are required to complete the 7 credit hours of core courses. The core courses, in particular ENVS 500, are the backbone of the MSc program, in which faculty and students from many different disciplines will analyze and discuss common environmental issues.
