### **Section 1: Mandatory Confirmations**

•I understand that the program dates are August 15, 2018 to December 20, 2018, and I will be present in San Diego during these dates.

•As a Business Courses Program student, I have previously passed business courses and can provide proof (upon request) with an academic transcript (English only). Business Courses Program students should have the required prerequisites to enroll in Special Sessions.

•I understand that enrolling in courses outside of the College of Business Administration may improve my ability to take courses with American students. The College of Business Administration (CBA) is highly impacted, so students may experience difficulty enrolling in courses that are in high demand. Departments in the College of Business Administration include: Accounting [ACCTG], Business Administration [BA], Finance [FIN], Management [MGT], Management & Information Systems [MIS], and Marketing [MKTG].

•In the American university system, business students enroll in both business and general (non-CBA) courses. I am prepared to enroll in business and general courses and will submit a list of all courses to my home university advisors/professors for approval.

•I understand that Semester at SDSU students will use an automated class enrollment system and, if placed on a class waitlist, will not have priority enrolling in classes.

•I understand that I am required to attend all of my classes for the entire length of each class; therefore, I am not permitted to enroll in any classes that would require me to be in two places at the same time. I agree to enroll in courses that do not overlap in day or time, not even by one minute.

•I understand that enrollment will be restricted in certain departments, such as Nursing, International Business, and Speech Language & Hearing Sciences. If I am enrolled in a course from the automated class enrollment system, I may be dropped from the course by the professor or department if I do not satisfy the requirements of the course.

•I understand that I must bring my transcript (English only) with me and have it readily available for viewing by staff and professors. I must make sure I have satisfied all prerequisites for a course. Professors have the authority to enforce prerequisites and may drop me from courses if I do not have the prerequisites or equivalent preparation for the course.

•I understand that the ALI cannot guarantee enrollment in specific university courses. Semester at SDSU students enroll in courses on a space-available basis after matriculated SDSU students have enrolled.

•I understand that if my inability to enroll in my preferred courses will have a negative effect on my ability to graduate from my home university, then I will need to reconsider attending this program. I may have to enroll in courses that are not my preference if space is not available.

•I must be enrolled as a full-time student to maintain my F-1 visa status. Full-time status is 12 units for undergraduate students and 9 units for graduate students.

•I understand that I can be dismissed at any time during the term if I have an attendance problem, behavior problem, do not work up to the high standards of the ALI, or if I do not pay tuition and fees.
