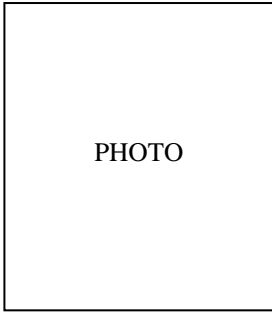

**Consent Agreement:**
