Further steps

After acceptance, a **compulsory health insurance** or **European Health Insurance Card** (EHIC – European citizens) will be required. The insurance must cover your stay in Spain for emergency medical treatment (including Covid-19), accidents, illness, civil liability and repatriation. It must cover the entire period of the programme.

Payment method

You will receive a registration confirmation with the final tuition fees you must pay according to the amount of ECTS enrolled. The bank details will be provided in order to make the wire transfer. A copy of the payment confirmation will be required.

When you have paid the fees, we will send you a letter of acceptance so you can apply for a visa, if necessary.
